



## Postal application for a Levy Payer Parking Pass 24/25 £7.50 each – 1<sup>st</sup> June 2024 to 31<sup>st</sup> May 2025 (for motor cars and motorcycles only)

The Malvern Hills Trust issues Levy Payer parking passes to residents of the town of Malvern and the parishes of Colwall, Guarlford, Malvern Wells, Mathon, and West Malvern who pay a levy to Malvern Hills Trust.

**Up to 3 passes can be purchased for vehicles registered to the levy address.**

### Proof of eligibility

- Copy of the vehicle registration document (**V5C**) for each vehicle must be produced, each time a pass is requested or renewed.

**AND**

- Proof of applicant's address in the Levy area - current **council tax bill** (*we are unable to accept utility bills/ pension or bank statements*).
