



Application Form for Levy Payer Parking Pass £8.00 each - 1st June 2026 to 31st May 2027

Concessionary passes are available to residents of Malvern and Parishes who pay the Levy to the Malvern Hills Trust via their Council Tax.

Up to 3 passes can be purchased for vehicles registered to the levy address.

Proof of eligibility

To avoid disappointment these are the ONLY two documents we will accept.

- Copy of the **vehicle registration document (V5C) (front page only)** must be produced each time a pass is requested or renewed.
Lease Car, Company Car and Motability car owners will need to provide documentation from the company to prove that the car belongs to you and is registered to you at your Malvern address and is not a pool car
- AND**
- Current **Council Tax Bill**
(we do not accept voting cards, utility bills, pension or bank statements).

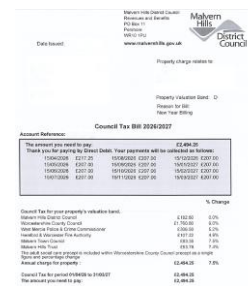
